1. Cancellation of the repurchased 3,500 units of Convertible Bonds at a face value of HK\$10,000 each on 8 April 2009.

2. As per the Company's announcement dated 22 April 2009, holders of a principal amount of the Convertible Bonds for HK\$1,226,280,000 has served early redemption notices requiring the Company to redeem their respective bonds at 115.97% on 8 May 2009 (the "Early Redemption") and the relevant bonds will be cancelled after the Early Redemption. The principal amount of the Convertible Bonds will then be reduced to HK\$82,720,000 pursuant to which the number of shares may be issued are 16,283,464 new shares.
