1. INTRODUCTION

On 18 October 2010, in conjunction with the announcement of the audited consolidated results of the Group for the financial year ended 30 June 2010, the Board has recommended the payment of a final dividend of HK\$0.06 per Share for the financial year ended 30 June 2010.

LETTER FROM THE BOARD

At the 2009 AGM, general mandates were given to the Directors to exercise the powers of the Company to repurchase Shares and to issue Shares. Such mandates will lapse at the conclusion of the Annual General Meeting unless they are renewed at that meeting.

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the Annual General Meeting, which include the re-election of the Retiring Directors and the grant of the Repurchase Mandate and Share Issue Mandate. Detailed explanations are provided to enable you to make an informed decision on whether to vote for or against them.

2. RE-ELECTION OF RETIRING DIRECTORS

In accordance with Article 116A of the Articles of Association, every Director shall retire from office at an annual general meeting by rotation at least once for every three consecutive annual general meetings and such Director shall retain office until the close of the meeting at which he retires and shall be eligible for re-election. The Retiring Directors shall retire by rotation at the Annual General Meeting and being eligible, offer themselves for re-election thereat.

Information on the Retiring Directors required to be disclosed under the Listing Rules is set out in Appendix I to this circular. A separate resolution for re-electing each of the Retiring Directors will be put forward at the Annual General Meeting.

3. GENERAL MANDATE TO REPURCHASE SHARES

An ordinary resolution will be proposed at the Annual General Meeting to give the Directors the Repurchase Mandate to purchase Shares not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company at the date of passing of the resolution, for the period until the conclusion of the next annual general meeting of the Company or such earlier period as stated in the resolution.

An explanatory statement as required under the Listing Rules to provide the requisite information regarding the Repurchase Mandate is set out in Appendix II to this circular.

4. GENERAL MANDATE TO ISSUE SHARES

An ordinary resolution will be proposed at the Annual General Meeting to give the Directors the Share Issue Mandate to allot, issue and deal with Shares up to 10% of the aggregate nominal amount of the issued share capital of the Company at the date of passing the resolution, for the period until the conclusion of the next annual general meeting of the Company or such earlier period as stated in the resolution.

Subject to the passing of the aforesaid ordinary resolutions of the Repurchase Mandate and the Share Issue Mandate, an ordinary resolution will also be proposed to extend the Share Issue Mandate by adding to it the number of Shares purchased by the Company under the Repurchase Mandate.

5. CLOSURE OF REGISTER OF MEMBERS

The register of members of the Company will be closed from Friday, 26 November 2010 to Tuesday, 30 November 2010 (both dates inclusive). During this period, no transfer of Shares will be registered. In order to qualify for the Final Dividend, all completed transfer forms accompanied by the relevant share certificates must be lodged with the Company's share registrars in Hong Kong, Tricor Abacus Limited, at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong not later than 4:00 p.m. on Thursday, 25 November 2010.

6. ANNUAL GENERAL MEETING

There is set out on pages 11 to 14 of this circular a notice convening the Annual General Meeting.

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll. The Chairman of the Annual General Meeting will exercise his power under Article 80 of the Articles of Association to put the resolutions to be proposed at the Annual General Meeting to vote by way of poll. The results of the poll will be published on the websites of the Company and the Stock Exchange in accordance with Rule 13.39(5) of the Listing Rules.

Article 85A of the Articles of Association provides, inter alia, that on a poll every member present in person (or, in case of a member being a corporation, by its duly authorised representative) or by proxy shall have one vote for each share registered in his name in the register and such person, if entitled to more than one vote, is under no obligation to cast all his votes in the same way. A member being a corporation may, by resolution of its directors or other governing body or by power of attorney, authorise such person as it thinks fit to act as its representative at the Annual General Meeting in accordance with Article 96(a) of the Articles of Association.

A form of proxy is enclosed for use at the Annual General Meeting. Whether or not you are able to attend the Annual General Meeting, you are requested to complete and sign the form of proxy as instructed thereon and deposit it at the principal office of the Company in Hong Kong at Room 2705, 27th Floor, China Resources Building, 26 Harbour Road, Wanchai, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding of the Annual General Meeting or any adjournment thereof. Delivery of the form of proxy will not preclude you from attending and voting in person at the Annual General Meeting under which circumstances, the instrument appointing a proxy shall be deemed to be revoked.

7. RECOMMENDATION

The Directors consider that the proposed resolutions to be transacted at the Annual General Meeting, including the re-election of Retiring Directors, the grant of the Repurchase Mandate and the Share Issue Mandate, and the extension of the Share Issue Mandate to cover the Shares purchased by the Company pursuant to the Repurchase Mandate are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of all proposed resolutions at the Annual General Meeting.

**APPENDIX I INFORMATION ON RETIRING DIRECTORS PROPOSED
TO BE RE-ELECTED AT THE ANNUAL GENERAL MEETING**

The particulars of the Retiring Directors as referred to in resolution numbered 3 of the notice of the Annual General Meeting, proposed for re-election, are as follows:

Dr. LI Yan, aged 46, is responsible for the Group's research and innovation technology management. He received his master and doctorate degrees in Plant Nutrition and Horticulture from Fujian Agricultural University respectively and was appointed as professor of the Faculty of Horticulture at the same university. Dr. Li has extensive experience in agricultural farming, particularly in the areas of planting and cultivation methods, as well as pest and disease management. He joined the Group in January 1997.

Dr. Li has no specific term of service with the Company, which may be terminated by either party by written notice of not less than three months. He is, however, subject to retirement from office by rotation and re-election at annual general meeting in accordance with the Articles of Association. The total emoluments paid and payable to Dr. Li for the financial year ended 30 June 2010 were RMB232,000, details of which are specified in note 14 to the financial statements of the 2009/2010 Annual Report.

As at the Latest Practicable Date, Dr. Li did not have any interests in the Shares within the meaning of Part XV of the SFO nor any relationship with any directors, senior management or substantial or controlling shareholders of the Company.

Ms. HUANG Xie Ying, aged 62, is primarily responsible for the Group's finance management function. She graduated from Xiamen Economic College. Ms. Huang joined the Group in January 1997 and has over 18 years of extensive accounting experience in the PRC. Ms. Huang was appointed as an executive director of the Group on 1 September 2003.

Ms. Huang has no specific term of service with the Company, which may be terminated by either party by written notice of not less than three months. She is, however, subject to retirement from office by rotation and re-election at annual general meeting in accordance with the Articles of Association. The total emoluments paid and payable to Ms. Huang for the financial year ended 30 June 2010 were RMB529,000, details of which are specified in note 14 to the financial statements of the 2009/2010 Annual Report.

As at the Latest Practicable Date, Ms. Huang did not have any interests in the Shares within the meaning of Part XV of the SFO nor any relationship with any directors, senior management or substantial or controlling shareholders of the Company.

Mr. IP Chi Ming, aged 49, was formerly an executive director of the Company until 8 January 2010 when he has been re-designated as a non-executive director of the Company. Mr. Ip is a director of some of the subsidiaries of the Company. He is also the non-executive vice chairman of Asian Citrus Holdings Limited, an associated company of the Company listed on the Alternative Investment Market of the London Stock Exchange and The Stock Exchange of Hong Kong Limited. Mr. Ip has also acted as an executive director of Suncorp Technologies Limited, a company listed on The Stock Exchange of Hong Kong Limited, since 25 February 2010. Mr. Ip has over 20 years of experience in trading and marketing in the food products industry as well as extensive experience in corporate strategic planning, overall management, business development, sales and marketing.

Mr. Ip has been appointed by the Company for a term of two years until 7 January 2012. Such an appointment may be terminated by either party by a written notice of not less than three months. He is, however, subject to retirement from office by rotation and re-election at annual general meeting in accordance with the Articles of Association. The total emoluments paid and payable to Mr. Ip for the financial year ended 30 June 2010 were RMB1,184,000, details of which are specified in note 14 to the financial statements of the 2009/2010 Annual Report.

As at the Latest Practicable Date, Mr. Ip did not have any interests in the Shares within the meaning of Part XV of the SFO nor any relationship with any directors, senior management or substantial or controlling shareholders of the Company.

Ms. LUAN Yue Wen, aged 50, holds a professional diploma in Computer Science, a professional diploma in Economic Law, a professional diploma in Financial Accounting, a Master Degree in Business Administration and a Master Degree in Building Construction and Real Estate Project Management. Ms. Luan has over 20 years of experience in the financial accounting and auditing field. Ms. Luan is a member of the Chinese Institute of Certified Public Accountants and also a member of the Chinese Institute of Valuers. Ms. Luan has been an independent non-executive director of the Company since 20 September 2004 and is a member of the Audit and Remuneration Committees of the Company.

Ms. Luan has been appointed by the Company for a term of two years until 19 September 2012. Such an appointment may be terminated by either party by a written notice of not less than three months. She is, however, subject to retirement from office by rotation and re-election at annual general meeting in accordance with the Articles of Association. The total emoluments paid and payable to Ms. Luan for the financial year ended 30 June 2010 were RMB238,000, details of which are specified in note 14 to the financial statements of the 2009/2010 Annual Report.

As at the Latest Practicable Date, Ms. Luan did not have any interests in the Shares within the meaning of Part XV of the SFO nor any relationship with any directors, senior management or substantial or controlling shareholders of the Company.

Save as disclosed above, there are no other matters that need to be brought to the attention of the Shareholders regarding the re-election of the Retiring Directors nor any other information needs to be disclosed pursuant to any of the requirements of Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

This explanatory statement contains the information required under Rule 10.06(1)(b) of the Listing Rules. Its purpose is to provide the Shareholders with information reasonably necessary to enable them to make an informed decision on whether to vote for or against the resolution approving the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 3,344,204,491 Shares. At that date, the Company repurchased 1,000,000 Shares on the Stock Exchange and such Shares have not yet been cancelled. It is expected that such Shares will be cancelled before the date of the Annual General Meeting. Assuming there are no issue of Shares or any further repurchases of Shares from the Latest Practicable Date up to the Annual General Meeting, the total number of Shares in issue as at the date of the Annual General Meeting will be 3,343,204,491 Shares.

Subject to the passing of the ordinary resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 334,320,449 Shares.

2. REASONS FOR REPURCHASES OF SHARES

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders as a whole. Whilst it is not possible to anticipate in advance any specific circumstance in which the Directors might think that it is appropriate to repurchase Shares, they believe that an ability to do so would give the Company additional flexibility that would be beneficial to the Company and the Shareholders as such repurchases may, depending on market conditions and funding arrangements at that time, lead to an enhancement of the net asset value per Share and/or earnings per Share.

3. FUNDING OF REPURCHASE

In repurchasing securities, the Company may only apply funds legally available for such purposes in accordance with its memorandum and articles of association of the Company, the Listing Rules and the applicable laws of the Cayman Islands. Under the laws of the Cayman Islands, repurchases by the Company may only be made out of profits of the Company or out of the proceeds of a fresh issue of Shares made for the purpose, or, if so authorised by the Articles of Association and subject to the provisions of the laws of the Cayman Islands, out of capital.

On the basis of the consolidated financial position of the Company as at 30 June 2010 (being the date to which the latest published audited financial statements of the Company have been made up), and in particular the working capital requirements of the Company as at 30 June 2010 and the number of Shares in issue as at the Latest Practicable Date, the Directors consider that there might be an adverse impact on the working capital position and the gearing position of the Company in the event that repurchases of all the Shares under the Repurchase Mandate were to be carried out in full during the period of the Repurchase Mandate.

The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

5. UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules, the memorandum and articles of association of the Company and the laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their associates, have any present intention to sell any Shares to the Company in the event that the Repurchase Mandate is approved by the Shareholders at the Annual General Meeting.

No connected persons have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders at the Annual General Meeting.

6. TAKEOVERS CODE

If a Shareholder's proportionate interest in the voting capital of the Company increases as a result of repurchase(s) of Shares by the Company, such increase will be treated as an acquisition for the purposes of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert could, depending on the level of increase of his or their interest, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge of the Company, Mr. Kwok Ho and his associates were deemed to be interested in 643,092,644 Shares, representing approximately 19.23% of the issued share capital of the Company. On the assumption set out in paragraph 1 of this explanatory statement that the number of Shares in issue will be 3,343,204,491 Shares and in the event that the Directors exercise the power to repurchase Shares in full pursuant to the Repurchase Mandate, the shareholding of Mr. Kwok Ho and his associates in the Company will be increased to approximately 21.37%. In the opinion of Directors, such increase may not give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code.
